



HARD RED WINTER WHEAT GRAIN POLICY 2021

(SUBJECT TO CHANGE WITHOUT NOTICE)

This harvest policy shall take effect on all Hard Red Winter Wheat delivered on or after June 21, 2021.

STORAGE POLICY

Hard Red Winter Wheat delivered shall be placed into Open Storage unless otherwise indicated. The following charges will apply:

- No charges if sold within 15 days from average delivery date.
- Wheat not sold within 15 days from average delivery date shall be subject to storage at the rate of \$0.00165 per bushel per day until sold. This is equivalent to 4.95¢ per bushel every 30 days.
- Warehouse Receipts will be available. Prepayment of storage is required at time the warehouse receipt is issued. Payment of any applicable discounts shall also be payable at the time the warehouse receipt is issued. The prepayment of storage shall be calculated at \$0.00165 per bushel per day from the average date of delivery through the end of the 9-month loan maturity. Unused storage will be returned at settlement time.
- First wheat delivered goes towards contracts. Application will occur at delivery.

DOCKAGE

Weight reduction on any fraction of a percentage found in the sample. I.e. .10% is a reduction of one-tenth of a percent in net pounds for the load.

I.e. A dockage factor of 2.2% equates to a loss of 2.2% of the net weight and a cash discount of 10.0¢ per bushel.

In the event of sprout or scab damage a sample of the load will be submitted for an official grade for determination of damage content. Additionally, if scab is present, a sample will be submitted to Hastings Grain Inspection for determination of presence of vomitoxin. Vomitoxin discounted at rate in schedule below.

HELPFUL HINTS WHEN DELIVERING YOUR GRAIN AT HARVEST

- When coming on to the scale, display a sign in the window showing tenant and landlord(s) name and splits. It is also helpful to place the account number on the sign.
- Make sure your driver is aware of whose grain they are delivering. Have them check the names on scale tickets before they leave the elevator after unload. Please notify scale operator when the last load is delivered off a particular split.
- All grain delivered will be available for settlement the day following delivery.
- When you call to settle grain, please inform our grain accounting personnel who you are, who your landlord/tenant is, the division of the grain and what grain is involved.
- If you want to sell your grain across the scale, please make sure the operator is aware of this at the time of delivery. Grain sold across the scale will be priced as of that day’s closing bid.
- Checks will be held for you to pick up at your location unless we are instructed to mail them. If you wish to have the payment deferred until 2021, please tell your location personnel.

To prevent errors, we request that you verify with our personnel, the total number of loads delivered at the time of settlement. We ask you to do this as it reduces the possibility of posting errors and increases our timeliness on writing your checks. We will not write any checks unless loads are verified. Checks will not be issued until you instruct us to do so. This precaution is being taken to reduce errors along with extra work if you wished to defer the income from the sale.

GRAIN POLICIES By delivery commodities to CPI, Customer acknowledges and agrees that:

- The storage agreement between the Customer and CPI shall be subject to the terms of these Grain Policies. This agreement shall be subject to the Nebraska Grain Warehouse Act and the accompanying administrative regulations thereunder.
- Customer represents that it has good title to the grain, and has authority to ship, store and sell it through CPI.
- Deliveries may remain unsettled for 15 days from first day of delivery. After 15 days, the delivery closes and if no disposition, the grain will be placed into open storage and shall accrue storage charges from the original date of delivery. Deliveries of grain may be co-mingled by CPI.
- CPI shall have a lien against the grain stored for all charges for storage and handling, and those related to its preservation (including drying), at the rates set forth in these Grain Policies; and Customer hereby grants to CPI a security interest in said grain to the extent of such charges and fees.
- Drying/storage/handling charges on open storage grain are due upon the earlier of; (i) request by CPI; or (ii) date of sale prior to transfer of title, or removal of the grain from open storage.
